LDZD - ZADAR/Zemunik Airport - Renewal of asphalt pavement, construction of new part of the Main apron and passenger terminal extension

INTRODUCTION 1.

Works on renewal of asphalt pavement, construction of new part of the Main apron and passenger terminal extension will be carried out from the end of January, and with expected duration until the mid of June.

These works will be carried out at the following areas:

Location 1 – Main apron, except north part along current PSN 7, PSN 8 and PSN G3-G15.

Location 2 – between Main apron and General aviation apron and TWY K and L.

SCHEDULE OF THE CONSTRUCTION WORKS 2.

Works on locations:

- Phase 1 Works on Location 1 will include renewal of asphalt pavement, starting at the end of January and with expected duration till mid of March.
- Phase 2 Works on Location 2 include construction of new concrete part of the Main apron, starting at the end of January and with expected duration till mid of June.

Works on Locations 1 and 2 will be carried out simultaneously.

3. **OPERATIONAL IMPACTS**

During works on Location 1 and Location 2, RWY 04/22, TWY K and L will be closed.

Two different Index ADPC charts, APDC 1 and APDC 2, show available parking positions on apron during the Phase 1 and Phase 2.

ADPC 3 Index chart shows all parking positions on the Main apron and General aviation apron upon completion of works. These APDC charts are part of this AIP SUP.

Phase 1

During this phase parking positions PSN 1 - 10, A - E, NG1 - NG5 and NG11 - NG12 will not be available for use.

Parking positions G3 - G15, NG 6 - NG 10 and new, alternative PSN A1 and PSN A2, will be opened.

Works on Location 1 will be finished at the mid of March.

Upon completion works on Location 1, that part of apron will be opened for traffic and parking.

ADPC 1 Index chart shows works area on Locations 1 and 2 - these areas will be surrounded by fence as part of landside.

Phase 2

During this phase, parking positions NG1 - NG5, NG11 - NG12 will not be available for use. TWY L will be withdrawn permanently.

New parking positions will be opened, pushback positions PSN 3, 4, 5, 6, 7, 8 will be installed. PSN 1, 2 will be self-manoeuvring.

Works on Location 2 will be finished at mid of June.

ADPC 2 Index chart shows works on Location 2 – the area will be surrounded by fence as part of landside.

"Follow me" guidance is mandatory. All aircraft on arrival and departure must follow "Follow me" vehicle.

All changes will be additionally promulgated by NOTAM.

INS coordinates of new parking positions will be published by PERM NOTAM.

4. PRECAUTIONS

PPR is mandatory for all flights, except those that have already confirmed according to schedule coordination.

During works, pilots are advised to be aware of the following:

- (a) Presence of possible obstacles, particularly the vehicle cranes on the construction site, which will be marked by adequate obstacle visual aids for denoting obstacles according to ICAO Annex 14.
- (b) Presence of construction sites which will be delineated by adequate fences and markers.


