LDZD – ZADAR/Zemunik Airport - Construction of new part of the Main apron and changes of parking procedures at the apron

1. INTRODUCTION

Construction of new concrete part of the Main apron. The existing self-manoeuvring PRKG PSN will be subject of change in way that new parking positions from PSN 1 to PSN 10 will be pushback PRKG PSN.

2. COMPLETION OF CONSTRUCTION WORKS

The construction works will be completed by the end of June. During the construction works on Main apron, RWY 04/22 will be closed for all traffic. Appendix 1 - INDEX CHART, that is part of this AIP SUP, shows plan of how PRKG PSN on the Main and General aviation aprons will be reorganised after completion of all works. AIP Chart LDZD AD 2.24.2 APDC-1 is suspended.

3. OPERATIONAL IMPACTS

RWY 04/22 is closed to all traffic. Due the closure of RWY 04/22 limitations in number of movements per hour can be expected. As a result, certain procedures will be put in place for arrivals and departure.

"Follow me" guidance is mandatory due to WIP on apron and new respective local AD regulation. Five new pushback and two selfmaneuvering positions are installed.

When more than one aircraft is taxiing via TWY H on departure, "Follow me" guidance may be expected.

All changes will be additionally communicated trough NOTAM.

INS coordinates of PRKG PSN will be published by PERM NOTAM

4. PRECAUTIONS

PPR is mandatory for all flights, except those that have already been confirmed according to schedule coordination.


